1. Introduction

- 1.1. UNWOMEN invites qualified parties to submit Technical and Financial Proposals to provide services associated with the UNWOMEN requirement for (Implementing Partner/Responsible Party).
- 1.2. A description of the services required is described in CFP Section 4 -Terms of Reference.
- 1.3. UNWOMEN may, at its discretion, cancel the services in part or in whole.
- 1.4. Proponents may withdraw the proposal after submission, provided that written notice of withdrawal is received by UNWOMEN prior to the deadline prescribed for submission of proposals. No proposal may be modified subsequent to the deadline for submission of proposal. No proposal may be withdrawn in the interval between the deadline for submission of proposals and the expiration of the period of proposal validity.
- 1.5. All proposals shall remain valid and open for acceptance for a period of 90 calendar days after the date specified for receipt of proposals. A proposal valid for a shorter period may be rejected. In exceptional circumstances, UNWOMEN may solicit the proponent's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.

2. Cost of proposal

The cost of preparing a proposal, attendance at any pre-proposal conference, meetings or oral presentations shall be borne by the proponents, regardless of the conduct or outcome of the CFP process. Proposals must offer the services for the total requirement; proposals offering only part of the services will be rejected.

3. Eligibility

- 7.2. Proposals should be received by the date, time and means of submission stipulated in this CFP. Proponents are responsible for ensuring that UNWOMEN receives their proposal by the due date and time. Proposals received by UNWOMEN after the due date and time may be rejected.

11. Evaluation of technical and financial proposal

11.1.PHASE I – TECHNICAL PROPOSAL (70 points)

11.1.1.Only proponents meeting the mandatory criteria will advance to the technical evaluation in which a maximum possible 70 points may be determined. Technical evaluators who are members of a Committee for Partners' Assessment (CPA) appointed by UNWOMEN will carry out the technical evaluation applying the evaluation criteria and point ratings as listed below. In order to advance beyond Phase I of the detailed evaluation process to Phase II (financial evaluation) a proposal must have achieved a minimum cumulative technical score of 50 points.

11.2.PHASE II - FINANCIAL PROPOSAL (30 points)

11.2.1. Financial proposals will be evaluated following completion of the technical evaluation. The proponent with the lowest evaluated cost will be awarded 30 points. Other financial proposals will receive pro-rated points based on the relationship of the proponents' prices to that of the lowest evaluated cost

12. Preparation of proposal

- 12.1. You are expected to examine all terms and instructions included in the CFP documents. Failure to provide all requested information will be at proponent's own risk and may result in rejection of proponent's proposal.

Section 4: UN Women Terms of Reference

1. Introduction

a. Background

Community tensions have increasingly become a threat to global peace and harmony, with complex local, national and international inter-linkages. These extreme tensions are putting countries and societies at risk of conflict, notably by reinforcing divisions among social groups, by undermining the social contract between citizens and their state, and by marginalizing the forces of positive and constructive change.

There are strong gender dynamics underpinning radicalization and extremism, including the effect of propaganda, use of gender-based violence, and the varying roles that men and women play as supporters, mobilisers, and fighters. Many radical groups are also placing the control and subjugation of women and girls at the heart of their agendas, using gender-based stereotypes to radicalize and recruit, and undoing generations of progress on gender equality and women's rights. Given the gendered underpinnings of this agenda, the very promotion of gender equality is itself a counter-measure to the spread of radicalization. While no single driver of radicalization has been identified, many of the conditions conducive to extremism can be associated with factors that disproportionately affect women. Centrally, this includes structural inequality, which can leave women especially vulnerable to violence and exploitation. The UN Women's programme will ensure that accountability frameworks are adopted and implemented by Member States. Additionally, they will promote the systematic integration of gender-inclusive perspectives in the development, implementation, and evaluation of counterterrorism and its prevention in programming. For analysis and data elements, gendered analysis will be utilized to assess specific drivers, threats, and resilience factors for women, men, boys, and girls in different regions. The project will also seek to mobilize and support women's organizations at grassroots levels, who are key actors in prevention, early warning, and community resilience.

Justification:

Pakistan has fought a difficult battle with several groups during last two decades. While incidents of terrorism have seen a steady decline during last four years, in part due to law enforcement efforts of Pakistani state, extremism has emerged as the biggest challenge to national and community cohesion. Women, have been worst affected by the hostilities that saw men leaving homes in search of livelihoods as conflict limited the economic opportunities in their ancestral lands, leaving behind womenfolk to bear the brunt of insecurity and extreme poverty.

While extremist groups aim to exert influence over all individuals, they specifically target women's rights, seeking to dismantle many gains of the women's movement over the past decades. Notably, their strategies for radicalization are strongly influenced by gender dynamics. "Gender-specific" propaganda distilling tailored messages to young, adolescent, and adult males and females is a key push factor in recruitment. Sexual and gender-based violence has also become an important strategic objective, including a means to attract new recruits and control populations and territory. UN-led investigations have uncovered a wide range of abuses, ranging from violations of women's fundamental rights to health, education, and engagement in public life, to crimes such as rape, forced marriage, abductions, and sexual slavery. At the same time, women are themselves being recruited by these groups, both forcibly and willingly. On the other hand, counter-terrorism policies are also targeted towards women, often resulting in the curtailment of their rights and constraining their operating environment. Women and women's organizations suffer the impact of both extremist groups and strategies used to counter them – squeezed between terror and anti-terror. Responses to extremism, then, must fundamentally consider and address these dimensions.

b. General Overview of services required/results

The Project on "Social Cohesion through Women's Leadership" is an innovative initiative that aims to identify and evaluate the drivers of extremism and its gendered impacts. Activities under this project will be conducted to enhance the levels of tolerance and resilience in the communities and promote the participation of youth in social cohesion.

The primary aim is to achieve the above through Community and National dialogues, consultations on extremism with women's civil society organizations and networks, and by conducting nation-wide dialogues and meetings with National counter terrorism bodies. In addition, by engaging with opinion makers and community leaders to create alternative narrative to extremism and spread messages through advocacy and awareness. Finally, the above will support women's engagement by developing counter narrative messages using new and traditional media to develop peace, tolerance and co-existence to youth.

2. Description of required services/results

OUTCOME: Extremism is prevented by strengthening capacities of local actors from Pakistan (selected districts) to address its gendered dynamics.

The project proposes the following output/activities in Karachi and Thatta, Sindh:

Output 1. Expand and deepen a data-driven evidence base of the drivers of extremism and its gendered impacts.

- 1.1. Engage in 08 Community Dialogues at district level with the aim to collect information on perceptions of women on extremism and to understand where there may be future areas of research on prevention
- 1.2. Organization of 2 national dialogues on the gender impacts of extremism especially highlighting areas needed for further research and data collection through advocacy and awareness raising to feed into good practices for the UN, EU and other stakeholders working in this area

Output 2. Enhance capacities of national and local authorities to understand and effectively respond to the gendered dynamics underpinning extremism.

- 2.2 Organize a National level workshop for all stakeholders to plan and improve response and understanding of extremism based on the comprehensive research data
- 2.2.1 Conduct nation-wide dialogues and meetings with National counter terrorism bodies incl. Ministry of Interior, Women's Parliamentary Caucus, Women Machineries and Civil Society Organizations to sensitize them on gender dimensions of extremism and support in developing prevention strategies

Output 3. Strengthen women's active participation in policy dialogues and initiatives to prevent extremism and promote social cohesion.

- 3.1. Organize awareness sessions with women & civil society groups to identify early warning signs of extremism and participate in prevention efforts through dialogue and resilience, thus enabling capacity building of women to identify early signs of violence and extremism
- 3.2. Organize 4 trainings for women in communities on identification of early signs of extremism

- 3.3. Engage with opinion makers and community leaders to create alternative narrative to extremism and spread messages through advocacy and awareness
- 3.4. Support women's engagement by developing counter narrative messages using new and traditional media to develop peace, tolerance and co-existence to youth
- 3.4.1. Develop a Media campaign (traditional & social) to support women's engagement for developing peace, tolerance & co-existence
- 3.5. Implement ten skills development sessions to strengthen women's economic resilience

The project duration is two years starting from the date of signing of agreement (tentative time line is November 2019 – October 2021).

Proponents are requested to complete form Annex B1-2 and return it as part of their submission. Proponents must meet all mandatory requirements/pre-qualification criteria as set out in Annex B1-2. See section 3 (clause 10) below for further explanation. Proponents will receive a pass/fail rating on this section. To be considered, proponents must meet all the mandatory criteria described in Annex B1. UN WOMEN reserves the right to verify any information contained in proponent's response or to request additional information after the proposal is received. Incomplete or inadequate responses, lack of response or misrepresentation in responding to any questions will result in disqualification.

Component 1: Organizational Background and Capacity to implement activities to achieve planned results (max 1.5 pages)

This section should provide an overview with relevant annexes that clearly demonstrate that the proposing organization has the capacity and commitment to implement successfully the proposed activities and produce results. Key elements to be covered in this section include:

- 1. Nature of the proposing organization Is it a community-based organization, national or subnational NGO, research or training institution, etc.?
- 2. Overall mission, purpose, and core programmes/services of the organization
- 3. Target population groups (women, indigenous peoples, youth, etc.)
- 4. Organizational approach (philosophy) how does the organization deliver its projects, e.g., gender-sensitive, rights-based, etc.
- 5. Length of existence and relevant experience
- 6. Overview of organizational capacity relevant to the proposed engagement with UN Women (e.g., technical, governance and management, and financial and administrative management)

Component 2: Expected Results and Indicators (max 1.5 pages)

This section should articulate the proponent's understanding of the UN Women Terms of Reference (TOR). It should contain a clear and specific statement of what the proposal will accomplish in relation to the UN Women TOR. This should include:

- The problem statement or challenges to be addressed given the context described in the TOR.
- The specific results expected (e.g., outputs) through engagement of the proponent. The expected results are the measurable changes which will have occurred by the end of the planned intervention. If not provided in the TOR, the expected results should have corresponding indicators, baselines and targets. Propose specific and measurable indicators which will form the basis for monitoring and evaluation. These indicators will be refined and will form an important part of the agreement between the proposing organization and UNWOMEN.

Component 3: Description of the Technical Approach and Activities (max 2.5 pages)

This section should describe the technical approach and should be able to show the soundness and adequacy of the proposed approach, what will actually be done to produce the expected results in terms of activities. There should be a clear and direct linkage between the activities and the results at least at the output level. Specific strategies should also be described to support the achievement of results, such as building partnerships, etc.

Activity descriptions should be as specific as necessary, identifying **what** will be done, **who** will do it, **when** it will be done (beginning, duration, completion), and **where** it will be done. In describing the activities, an indication should be made regarding the organizations and individuals involved in or benefiting from the activity.

This narrative is to be complemented by a tabular presentation that will serve as Implementation Plan, as described in Component 4

Component 4: Implementation Plan (max 1.5 pages)

This section is presented in tabular form and can be attached as an Annex. It should indicate the **sequence of all major activities and timeframe (duration).** Provide as much detail as necessary. The Implementation Plan should show a logical flow of activities. Please include in the Implementation Plan all required milestone reports and monitoring reviews.

Component 6: Results-Based Budget (max. 1.5 pages)

The development and management of a realistic budget is an important part of developing and implementing successful activities. Careful attention to issues of financial management and integrity will enhance the effectiveness and impact. The following important principles should be kept in mind in preparing a project budget:

- Include only costs which directly relate to efficiently carrying out the activities and producing the results which are set forth in the proposal. Other associated costs should be funded from other sources.
- The budget should be realistic. Find out what planned activities will actually cost, and do not assume that you will be able to make do for less.
- The budget should include all costs associated with managing and administering the activity. Particularly include the cost of monitoring and evaluation.
- Indirect costs, or administrative overhead costs, such as staff salaries and office rent are not funded. These therefore should not be part of the funding request.
