#### BACKGROUND

The United Nations Entity for Gender Equality and the Empowerment of Women (UN Women) strives to promote gender equality and women’s human rights, to strengthen implementation of gender sensitive policy and legislation, and to eliminate all forms of violence against women. The strategy in Pakistan encompasses strengthening the capacity of government, non-governmental organizations and UN system to deliver on Pakistan’s national and international commitments on gender equality and women’s empowerment by ensuring that voices of women and human rights-based approach is integrated fully in the development agenda of the country.

UN Women Pakistan’s **Women’s Economic Empowerment (WEE) Programme** has been supporting the implementation of national commitments and international frameworks around economic opportunities for women since 2007, and in particular supporting the development of provincial homebased workers’ policies and laws to improve the working conditions of the many rural and urban women in Pakistan undertaking informal homebased work.

UN Women’s main objective in the WEE area is to empower women to fully participate in economic life across all sectors and at all levels of economic activity so that they have better chances to earn higher incomes, have increased access and control over resources and have greater security and protection from violence. The WEE programme interventions are aligned with UN Women’s global strategic plan results and focus on economic empowerment of excluded women groups in the country.

Gender equality is not only a fundamental human right, but a necessary foundation for a peaceful, prosperous and sustainable world. Providing women and girls with equal access to education, health care, decent work, and representation in political and economic decision-making processes can fuel sustainable economies and benefit societies and humanity at large.

## **Situational analysis - Pakistan**

Despite the reported economic growth in the past few years, Pakistan is ranked 148 (out of 149 countries) in the World Economic Forum’s Gender Gap Report 2018, and the same report ranks Pakistan 146 out of 148 countries in the index on Economic Participation and Opportunity, and 97 in the index on Political Empowerment. The issue of women’s economic and political rights has been a major concern for the nation, especially for the most marginalized segments of society such as single women, rural women, transgender groups, women with disabilities and HIV/AIDS-affected women.

Pakistan, with a population of 207 million<sup>1</sup>, is the 10<sup>th</sup> largest country in the world according to the size of the labour force. The recent labour force survey in Pakistan has pointed out that the percentage of women in labour force is only around 25%<sup>2</sup> and in urban areas it falls to only 12%<sup>3</sup>. Data reveals that female labour force participation in Pakistan is still well below levels in other countries with similar incomes, despite the growth by more than half over the past 2 decades. Even among women with a high level of education, labour force participation is low—only about 25% of Pakistani women who have a university degree work outside their home<sup>4</sup>. Women’s low labour force participation results in a significant potential loss of productivity. Women are increasingly concentrated in sectors like domestic work, home-based work, agricultural work, garment factories – in all forms of vulnerable work that have least protection. Besides socio-cultural barriers that hinder women’s opportunity for mobility, education and skills to participate in the workforce on an equal footing, research indicates that inadequate data on women’s unpaid work also impact their participation in the labour force<sup>5</sup>.

### **1. Justification**

To advance gender equality in society, budgets are one of the most powerful instruments as they allow to influence the allocation of resources, policy formulation and implementation. Including a gender perspective in the allocation and execution of government budgets is an essential step to promote women’s equitable access to public resources and to mainstream a gender perspective into national development. Gender mainstreaming in the budgetary process has a

transformational potential to reduce inequalities between women and men and remove barriers in equal access to public goods and services.

The first gender budget initiative was implemented in Australia in 1987 when a women’s budget statement was issued for the first time as part of the federal budget papers<sup>6</sup>. In 1989, a group of feminist academics and activists organized a Woman’s Budget Group for lobbying and analysis of UK economic policies on women<sup>7</sup>, which was able to influence the UK treasury over the design of the Child Care Tax (Article, 12). Since then, the notion of Gender-Responsive Budgeting (GRB) has kept gaining influence and has become widespread in 1995 with the Beijing Platform for Action when the United Nations called on governments to assess how public expenditures benefit women and to adjust budgets to contribute to gender equality.

In 2015, through the Sustainable Development Goals (SDGs), the international community committed to promote a better articulation of women’s empowerment programmes and a significant increase in investments to close the gender gap. The importance of gender equality is included in 11 SDGs, in addition to SDG 5 that specifically focuses on gender equality. SDG 5.c targets to “adopt and strengthen sound policies and enforceable legislation for the promotion of gender equality and the empowerment of all women and girls at all levels”. Indicators include the percentage of countries with systems to track and make public allocations to gender equality (with 37 fiscal indicators and 25 indicators related to public expenditure). In parallel, the 2015 Addis Ababa Agenda calls for all actors to mobilize maximum resources to implement new and existing gender equality commitments. This includes the necessity of gender responsive budgeting for strengthening transparency and equal participation in the budgeting process.

Gender responsive budgeting is a strategy to achieve equality between women and men by focusing on how public resources are collected and spent. GRB is a ‘gender-based assessment of budgets incorporating a gender perspective at all levels of the budgetary process and restructuring revenues and expenditures in order to promote gender equality’<sup>8</sup>. Gender responsive budgeting does not imply creating separate budgets for women and men, nor does it mean setting aside ‘X’ percentage of money for women-related schemes. Rather, the goal of gender responsive budgeting is to incorporate gender awareness into the policies, plans, and programs of government agencies at all stages of the budget cycle including formulation, discussion, scrutiny and debate. GRB ensures that resources are allocated in the budget based on the different needs and interests of gender groups.

The purpose of gender responsive budgeting is threefold<sup>9</sup>:

1. to promote accountability and transparency in fiscal planning;

2. to increase participation of women and men in the budget process, for example by undertaking steps to involve women and men equally in budget preparation;
3. to advance gender equality and women's rights.

In Pakistan, GRB is a relatively new project. Pakistan started the Gender Responsive Budget Initiative (GRBI) in 2005 in a project with UNDP and its cost sharing donors the Swiss Agency for Development and Cooperation (SDC) and the Royal Norwegian Embassy at the federal level in the province of Punjab. For the first year, GRBI focused on the Punjab and Federal Budgets in three sectors: Education, Health and Population Welfare. The tools used in the process were Gender-Aware Policy Appraisal; Gender-Aware Benefit Incidence Analysis; Gender-Aware Beneficiary Assessments; Gender-Aware Public Expenditure Tracking; Gender-Disaggregated Analysis of the Impact of Budget in Time Use; Gender-Aware Revenue Incidence Analysis; and Gender Budget Statement.

Between 2012 and 2016, UN Women supported the enhancement of capacities of national and provincial governments and related actors for gender-responsive budgeting. The Project provided technical support to the Ministry of Finance to integrate gender-responsive indicators into its plans and programmes. The Project assessed the capacities of the Women Development, Social Welfare, and Labour and Human Resource Departments in Punjab and Sindh, in order to identify gaps in the design and delivery of WEE projects. A total of 150 staff of provincial government departments in Punjab and Sindh gained enhanced understanding of WEE and how to incorporate such guidelines into government planning documents.

UN Women is now intensifying its efforts to promote GRB and is planning to build the capacity of 30 parliamentarians and 50 Government officials in facilitating gender responsive and disaggregated funds allocation and gender-based planning, programming and budgeting at the federal and provincial level.

## 2. Details of the assignment

In this context, UN Women is seeking the services of a consultant firm specialized in the area of gender-responsive budgeting. Under the overall guidance of the Deputy Representative and direct supervision of the Portfolio Manager WEE&, the consultant/firm will complete two assignments with the following objectives:

**Assignment:** Conduct capacity enhancement of 30 parliamentarians and 50 Government officials from Planning Commission, Provincial Departments of Planning and Development, Finance, Women Development, Social Welfare and Labour to facilitate the gender responsive and disaggregated funds allocation and gender-based planning, programming and budgeting at the federal and provincial level.

### Tasks and Responsibilities:

- a. Develop detailed work plan including methodology and timeline for achieving desired objectives and share with UN Women for feedback.
- b. Prepare an inception report, covering the background, objectives, methodological approach, work plan and deliverables (within two weeks of signing of the contract);
- c. Undertake a needs-assessment to evaluate the GRB knowledge and training needs of government officials.
- d. Develop training manuals based on the needs assessments.
- e. Deliver training sessions with the aim to:
  1. Raise awareness and understanding of gender issues and the importance of GRB for sustainable development in Pakistan;
  2. Build the capacity of the government to understand budget and associated policies to promote gender equality;
  3. Equip policymakers with tools that can bring gender focus to all financial plans and help support equitable resource distribution;
- f. Conduct a post-training evaluation to evaluate the impact of the trainings.
- g. Prepare a final report including background, objectives, methodology, activities conducted, results achieved, challenges and recommendations for next steps.

**Expected final deliverables include:**

- A comprehensive report of the work realized to complete assignment, including context, methodology, activities, results, challenges and recommendations for next steps.

The consultant/firm will submit the deliverable in hard and soft copies to UN Women, in print ready version (with designing, editing and formatting professionally completed).

Prior to the finalization and final submission of the deliverable, the consultant/firm will submit the draft deliverable to UN Women for review and incorporate all feedback from UN Women in the final version that will be submitted for approval.

**Expected non-final deliverables include:**

- An agreed work plan and inception report within two weeks of signing of contract that includes a proposed schedule of tasks, activities and deliverables, research tools to be developed.
- Training manuals based on the needs assessments within two months of signing the contract for review and feedback by UN Women

**REVIEW ETHICS**

Reviews in the UN will be conducted in accordance with the principles outlined in both UNEG Norms and Standards for Review in the UN System and by the UNEG ‘Ethical Guidelines for Review’. These documents will be shared with the selected firm. Reviewers are required to read the Norms and Standards and the guidelines and ensure a strict adherence to it, including establishing protocols to safeguard confidentiality of information obtained during the review.

**QUALIFICATION, EXPERIENCE AND COMPETENCIES:**

**Experts Profile:**

The consultant applying through the firm must fulfill the following criteria:

- At least 10 years of work experience, and significant experience in delivering trainings.
- A master’s degree in development studies, gender studies, public policy or other political/social sciences relevant to the position.
- Advanced knowledge and experience of economic and political development
- Advanced knowledge and experience of gender issues
- Proven technical knowledge and evidence of technical support for gender mainstreaming and/or gender-responsive budgeting in public policies.

- Specialized knowledge of the theoretical underpinnings of gender responsive budgeting, but also capacity to translate them into practice, offer clear guidance and provide practical advice to civil servants.
- Solid experience of the Pakistan specific women’s economic and political empowerment issues and familiarity with international norms and standards on gender equality in the national and regional context.
- Good understanding of Pakistan’s socio-political atmosphere and budgetary technicalities.
- Fully literate on information technology
- Effective communication and writing skills in English
- A verifiable reputation of integrity and competence. Please provide 3 references.
- Work experience with UN agencies or other international development agencies is an advantage.

## EVALUATION METHODOLOGY AND CRITERIA

---

### 1. Preliminary Evaluation

The proposals are checked for compliance of the following requirements:

**Legal Capacity:** Bidders may be a private, public or government-owned legal entity or any association with legal capacity to enter into a binding Contract with the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women).

**Conflict of Interest:** Bidders must disclose any actual or potential conflict of interest and they shall be deemed ineligible for this procurement process unless such conflict of interest is resolved in a manner acceptable to UN Women. Conflict of interest is present when:

- A Bidder has a close business or family relationship with a UN Women personnel who: (i) are directly or indirectly involved in the preparation of the bidding documents or specifications of the contract, and/or the bid evaluation process of such contract; or (ii) would be involved in the implementation or supervision of such contract;
- A Bidder is associated, or has been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by UN Women to provide consulting services for the preparation of the design, specifications, Terms of Reference, and other documents to be used for the procurement of the goods, services or works required in the present procurement process;
- A Bidder has an interest in other bidders, including when they have common ownership and/or management. Bidders shall not submit more than one bid, except for alternative offers, if permitted. This will result in the disqualification of all bids in which the Bidder is involved. This includes situations where a firm is the Bidder in one bid and a sub-contractor on another; however, this does not limit the inclusion of a firm as a sub-contractor in more than one bid.

Failure to disclose any actual or potential conflict of interest may lead to the Bidder being sanctioned further by UN Women.

**Ineligibility Lists:** A Bidder shall not be eligible to submit an offer if and when at the time of quotation submission, the Bidder:

- is included in the Ineligibility List, hosted by [UNGM](#), that aggregates information disclosed by Agencies, Funds or Programs of the UN System;

- is included in the [Consolidated United Nations Security Council Sanctions List](#), including the [UN Security Council Resolution 1267/1989 list](#);
- is included in any other Ineligibility List from a UN Women partner and if so listed in the RFP Instructions;
- is currently suspended from doing business with UN Women and removed from its vendor database(s).

**Code of Conduct:** All Bidders are expected to embrace the principles of the [United Nations Supplier Code of Conduct](#), reflecting the core values of the Charter of the United Nations. UN Women also expects all its suppliers to adhere to the principles of the [United Nations Global Compact](#) and recommends signing up to the [Women’s Empowerment Principles](#).

**Other Formal Requirements:**

- *Offers are signed by an authorized party, including Power of Attorney if stipulated;*
- *Bid security (format, amount and duration) are included, if requested;*
- *The offer is submitted as per the instructions to proposers ref: 4.1 and detailed in the Proposal Instruction Sheet above;*
- *The offer is valid;*
- *The offer is complete and eligible.*

**2. Cumulative Analysis Methodology:** A proposal is selected on the basis of *cumulative analysis*; the total score is obtained by combining technical and financial attributes.

A two-stage procedure will be utilized in evaluating the proposals; the technical proposal will be evaluated with a minimum pass requirement of [70%] of the obtainable [700] points assigned for technical proposal. A proposal shall be rejected at this stage if it fails to achieve the minimum technical threshold of [70%] of the obtainable score of [700] points prior to any price proposal being opened and compared. The financial proposal will be opened only for those entities whose technical proposal achieved the minimum technical threshold of [70%] of the obtainable score of [700] points and are determined to be compliant. Non-compliant proposals will not be eligible for further consideration.

The total number of points (“maximum number of points”) which a firm/institution may obtain for its proposal is as follows:

Technical proposal: 700 points

Financial proposal: 300 points

Total number of points: 1000 points

**Evaluation of financial proposal:**

In this methodology, the maximum number of points assigned to the financial proposal is allocated to the lowest price proposal. All other price proposals receive points in inverse proportion.

A formula is as follows:

$$p = y (\mu/z)$$

Where:

p = points for the financial proposal being evaluated

y = maximum number of points for the financial proposal

μ = price of the lowest priced proposal

z = price of the proposal being evaluated

The contract shall be awarded to the proposal obtaining the overall highest score after adding the score of the technical proposal and the financial proposal.

#### Evaluation of technical proposal:

The technical proposal is evaluated and examined to determine its responsiveness and compliancy with the requirements specified in this solicitation documents. The quality of each technical proposal will be evaluated in accordance with the following technical evaluation criteria and the associated weighting (total possible value of [700] points):
